Reports Mayor Report

Mayor Ed McGuire stated for discussion he would to ask the Council if they wanted to consider a Charter change to address the possibility of adding a filing fee to the election process for Dunes City candidates. The Council agreed to ask staff to look into putting a ballot initiative on the next election for a Charter change to match state law.

Mayor Ed McGuire also stated that once the Council was finished with the Nuisance Ordinance it would revisit the Septic Ordinance.
