RESOLUTION SERIES 2022, NO. 2

A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OF DUNES CITY TO USE A PORTION, BUT NO MORE THAN \$290,000.00
OF THE AMERICAN RESCUE ACT FUNDS TO ASSIST SMALL WATER SYSTEMS IN DUNES CITY IN UPGRADING AND MODERNIZING THEIR SYSTEMS FOR THE BENEFIT OF THE RESIDENTS WHO RELY ON THOSE WATER SYSTEMS; AND OTHER MATTERS RELATED THERETO.

WHEREAS, the City of Dunes City received funding from the United States Treasury for purposes of assisting residents who were adversely affected by activities resulting from the CORONA VIRUS PANDEMIC; and

WHEREAS, the language of the American Rescue Act allows such funding to be utilized to improve drinking water systems in municipalities; and

WHEREAS, several small drinking water systems in Dunes City have recently had issues with deterioration of system elements and design problems that oftentimes leaves the residents without a reliable water source for many days at a time; and

WHEREAS, Corona Virus pandemic related shut-downs, illnesses, and deaths of the property owners within those small drinking water systems have left them without the resources to make the improvements themselves; and

WHEREAS, it is in the best interest of all residents of Dunes City to have a reliable water source; and

WHEREAS, the City Council of Dunes City believes it to be in the best interests of the citizens of Dunes City for a portion of the funds received by the City to be utilized to assist small water systems to upgrade and modernize their systems.

NOW, THEREFORE, BE IT RESOLVED BY THE DUNES CITY COUNCIL AS FOLLOWS:

The City Council of Dunes City hereby authorizes the City Administrator of Dunes City to use a portion, but not more than \$290,000.00, of the American Rescue Act Funds received to assist small water systems in Dunes City in upgrading and modernizing their distribution systems.

The City Council further directs the City Administrator to develop a fair and equitable program for funding projects to achieve the directives of this Resolution; to keep all records in a manner mandated by the U.S. Treasury for reporting expenditures of said funds; and shall keep and provide monthly reports to the City Council of all expenditures made.

This Resolution shall be effective following its adoption by the City Council of the City of Dunes City.
